<u>DO NOT FILL</u> dumpster above the side rails; \$100.00 per hour service charge will apply to secure load or offload excessive materials on location for transport if loaded above the side rails.

If you have the dumpster positioned in the street/road; it is the responsibility of the individual signing this agreement to ensure any required permits from your city or township (or applicable governmental authority) are secured for the duration you have dumpster.

Once dumpster is placed; <u>DO NOT ATTEMPT TO MOVE</u> the dumpster; you are liable for any damages incurred to dumpster while in your possession. **SEE ATTACHED TERMS AND CONDITIONS.**

ITEMS <u>NOT PERMITTED</u> IN DUMPSTER: No hazardous materials, asbestos, compressed tanks (including but not limited to oxygen tanks, propane tanks, air compressor tanks, etc.), telephone poles, liquids of any kind, paint, biological waste, medical waste, toilet waste, tires, or car/truck batteries.

ALL KITCHEN/FOOD TRASH MUST BE BAGGED AND SEPARATED FROM OTHER DISCARDED CONTENTS. (Additional charges will apply if not followed.)

Additional disposal fees apply for all mattresses and box springs.

Special Note: Arrangements can be made for JMK Junk-Away to remove and dispose of tires and car/truck batteries for additional hauling & recycling fees. (Please consult with your JMK Junk-Away representative to discuss options.)

Payment Terms: Full rental payment is due upon delivery of dumpster.
