If you have the dumpster positioned in the street/road; it is the responsibility of the individual signing this agreement to ensure any required permits from your city or township (or applicable governmental authority) are secured for the duration you have dumpster.

Once dumpster is placed; DO NOT ATTEMPT TO MOVE the dumpster; you are liable for any damages incurred to dumpster while in your possession. **SEE ATTACHED TERMS AND CONDITIONS.**

**ITEMS NOT PERMITTED IN DUMPSTER: No hazardous materials, railroad ties, asbestos, televisions, computers and/or monitors, electronics, telephone poles, liquids of any kind, tires, paint, biological waste, medical waste, toilet waste, car/truck batteries or appliances.**

Special Note: Arrangements can be made for JMK Junk-Away to remove and dispose of tires, televisions, computers and/or monitors, electronics, car/truck batteries and appliances for additional hauling & recycling fees. (Please consult with your JMK Junk-Away representative to discuss options.)
